This agreement is available for use by all state agencies, schools, colleges, universities, cities, counties and other government entities in Mississippi.

Ordering Instructions

Orders must reference the contract #8200086201. Orders must include appropriate product items with correct color choices, quantities, net prices, ship-to location, a point of contact, and servicing dealer. Orders must show the correct net prices, otherwise the order will be turned for modification. Stylex requires a copy of the end-users PO when the order is made through the dealer.

Delivery/Installation

All freight, shipping and installation costs are the responsibility of the Manufacturer and are not reimbursable. All items must be transported F.O.B Destination. State agencies and governing authorities may elect to have furniture either delivered and installed or dock delivered. If dock delivery is selected, the Vendor shall deliver the furniture to the designated dock location only, and no installation services or installation charges shall apply.

Payment Terms

MS Code Section 31-7-305(3) allows a state entity to pay invoices within forty-five (45) days without penalty.

Warranty

Stylex standard warranty shall apply, please see warranty statement within the price list.

Cancellations/Return Policy

Cancellation of orders prior to production shall be at no charge. After production, cost incurred may be applicable. Returns will not be accepted without written authorization by Stylex. Agencies shall pay and bear responsibility for returns. Returns are subject to a restocking fee.

Servicing Dealer Responsibilities

Servicing Dealers are responsible for assisting any Mississippi agencies with any and all contract orders. Dealers are NOT allowed to change any contract term or condition, including products available, discounts, net prices or delivery. Dealers shall promote the contract in a professional manner. Dealers must familiarize themselves with the contract terms and conditions, and maintain appropriate insurance requirements. Dealers must also be in good standing with Stylex. Commissions are calculated on the net product sale only.
