Using the following guidelines, Stylex furniture products can be specified to meet the requirements for the Health Care Without Harm Healthy Interiors criteria, Version 2.4. Although we are confident that our finishes meet these requirements, it is not possible for us to test every textile combination available. The customer is responsible for specifying textiles that meet the Healthy Interiors criteria listed here.

PRODUCT SELECTION GUIDELINES

Formaldehyde

All of the Stylex products are currently UL GREENGUARD Certified to meet the formaldehyde emissions requirement. They have been tested in accordance with ANSI/BIFMA standard method M7.1/ X7.1-2011 R2016 and ANSI/BIFMA e3-2014e. Certificates are available on the Stylex website.

Polyvinyl Chloride (PVCs)

Not all Stylex Furniture products are 100% PVC free. Some non-work surface edges may contain PVC in an amount less than 1% of the total product weight.¹ Non-PVC edge banding is available on Grade 2 laminate work surfaces. Veneered work surfaces are PVC free. Some textiles may contain PVCs, so customers must specify PVC-free fabrics. Customers are responsible for COM textile treatments and chemical contents.

PFAS

Customers must select PFAS-free textiles available through our textile partners. Customers are responsible for COM fabric treatments and chemical contents.

Antimicrobials

Stylex does not add any antimicrobial chemicals to any of our products. Antimicrobial-free textiles are available through our textile partners. Some textiles may contain antimicrobial chemicals, so customers must specify antimicrobial-free textiles. Customers are responsible for the COM textile treatments and chemical contents.

Flame Retardants

All standard Stylex furniture products are available with flame retardant free materials unless specifically ordered to meet TB133. Some textiles may contain flame retardants, so customers must specify flame retardant free textiles. Customers are responsible for the COM textile treatments and chemical contents. Any product that includes an electrical device may contain added Flame Retardants.
